ENTRY CLOSING DATE: JUNE 30TH 2009**

Entry Forms and Payments:

Entry Forms: Download the **Eastern Creek Entry Confirmation documents** and complete and return them to SKA at the address below with entry fees or direct payment confirmation.

The **Shannons Series Entry Form** must also be completed by those who have not done so prior. Download this form, complete it by including your details and ticking only the appropriate Round box for Rounds you intend competing at, and return it with your event entry form. **SKA will accept entries from eligible Superkarters who were unable to run at Round 1 Mallala.**

Entry Fees must accompany the return of the Entry Form prior to June 30th 2009 and should be;
Cheque made payable to "Superkarts Australia Pty Ltd", or
Paid by Direct Deposit or EFT to the NAB account of "Superkarts Australia Pty Ltd" (details below).

The Entry Fees amount up to June 30th 2009 will be as follows;

Entrants who have paid their 2009 Series Registration Deposit with SKA, pay: **\$150***
* Entry fee \$400 less deposit paid \$250 = \$150

Entrants not registered with a SKA Series deposit paid are to pay: **\$450**

Dorian Transponders: Dorian transponders are mandatory for timing at this event, and you must supply your transponder number on the entry form. If you do not own a Dorian leave the number box blank, one will be allocated to you by the event manager at the event.

Race Numbers: SKA determines ASC Race Numbers. Entrants will use the Race Number they have registered with SKA[go to www.superkartsaustralia.org]. For Race Number enquiries contact SKA-enquiry@superkart.org.au

Series Registration Deposit: The \$250 deposits paid to SKA will be deducted from Round 2 entry fees.
